#### 5.3 Advice for firefighters

# **SECTION 7: Handling and storage**

Never use pressure to empty; the container is not a pressure vessel. Always keep in the same material as the supply container. Good housekeeping standards and regular safe removal of waste materials will minimise risks of spontaneous combustion and other fire hazards. The Manual Handling Operations Regulations may apply to the handling of containers of this product. Packs with a volume content of 5 litres or more may be marked with a maximum gross weight.
